WROUGHT IRON DOOR WARRANTY

Architecturals New Jersey LLC dba Amighini Architectural all Goods against manufacturing defects for 10 years on the iron door structure and mechanics, 5 years on the finish, and 5 years on the glass. Architecturals New Jersey LLC, at its sole discretion, will repair at a place of its choosing or replace all warranted defective goods. This warranty begins on the date of installation. All warranties are null and void if installation is found by Architecturals New Jersey LLC to be faulty in workmanship, in its sole discretion.

All products sold by Architecturals New Jersey LLC are “one of a kind” and as such contain slight “variations” in form, functionality, and finish. All product finishes may age relative to exposure. The finish is warranted against flaking or peeling from normal wear and tear. Doors may be cleaned with a mild soap and water mixture, as cleaning with harsh chemicals including ammonia based products (e.g. glass cleaner) may damage the finish. Doors installed in coastal areas must be ordered for coastal application and manufactured for such, as specified by Architecturals New Jersey LLC. Coastal door hinges require oil on an annual basis.

Architecturals New Jersey LLC warrants the glass from fogging as a result of normal operation for a period of 5 years. Scratches and other damages on glass or door finish as a result of pets or foreign objects or chemicals are not covered under this warranty.

All Iron door products exposed to below freezing climates may sweat on the interior of the door depending on the humidity level in the home. This is not considered to be a defect with the door, and will not harm the door.

Architecturals New Jersey LLC assumes no liability for any labor charges regarding the installation, removal, or reinstallation of doors. Damages caused by accident, misuse, abuse or improper installation are not covered under this warranty. This warranty does not cover damage caused by paint, acid or other chemicals. This warranty is strictly limited to the cost of repair or replacement of the product and Architecturals New Jersey LLC assumes no other liability. Locksets, hardware and other door components are covered under the conditions of the separate hardware warranties.

Architecturals New Jersey LLC. insulated glass units will be warranted against seal failure only if installed in the unit by Architecturals New Jersey LLC. Flaws in the glass will follow the “eleven foot rule” This means that “ A blemish shall not be detectable at a distance greater than eleven feet, when looking at the glass perpendicular to it using daylight or with background light suitable for observations of the blemishes.

Claims under this Limited Warranty must be made in writing within the period of this warranty and prior to the beginning of any repair work to: Customer Services, Architecturals New Jersey LLC, 246 beacon Ave, Jersey City, NJ 07306. Claims must detail the date and location of purchase, THE NATURE OF THE PROBLEM, and the name, address and telephone number of the person making the claim. Architecturals New Jersey LLC. reserves the right and must be given at least a thirty (30) day opportunity to have any door which is the subject of a warranty claim field inspected by an Architecturals New Jersey LLC. representative.

THIS LIMITED WARRANTY EXTENDS ONLY TO THE ORIGINAL PURCHASER OF PRODUCTS OR TO THE ORIGINAL PURCHASER OF THE STRUCTURE INTO WHICH SUCH PRODUCTS ARE INSTALLED.

This Limited Warranty sets forth Architecturals New Jersey LLC’s maximum liability for its iron products. Architecturals New Jersey LLC. makes no other warranty, expressed or implied, including implied warranties of merchantability and fitness for a particular purpose, with respect to its products except as set forth above. No distributor, dealer or representative has the authority to change or modify this Limited Warranty. In no instance shall Architecturals New Jersey LLC. be responsible for indirect, consequential or incidental damages.

This warranty gives you specific legal rights, and you may have additional rights which vary from state to state. Some states do not allow the exclusion or limitation of implied warranties or of incidental or consequential damages, so the limitation or exclusion may not apply to you. IN SUCH CASE, THE DURATION OF ANY IMPLIED WARRANTY SHALL BE THE SAME AS THAT OF THE EXPRESSED WARRANTY STATED HEREIN.

Architecturals New Jersey LLC. NEITHER ASSUMES NOR AUTHORIZES ANY OTHER PARTY TO ASSUME FOR IT, ANY OTHER LIABILITY.

IN NO EVENT SHALL Architecturals New Jersey LLC BE LIABLE FOR ANY INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES.

All warranty returns must have Architecturals New Jersey LLC authorization before the product(s) are shipped back. Architecturals New Jersey LLC requires that any return be given prior authorization by your Architecturals New Jersey LLC sales representative or by the Architectural Inc. dba AMIGHINI home office before returning items for claim or credit. All returns must be accompanied by a completed Return of Merchandise Authorization issued by Architecturals New Jersey LLC

Architecturals New Jersey LLC Limited Warranty does not cover product that has been rendered unusable due to damage or mishandling. A significant percentage of the items returned to Architecturals New Jersey LLC for warranty claim is product that has been damaged or mishandled after shipment. Architecturals New Jersey LLC NI will not recognize such situations as legitimate claims covered under this warranty.

Please be aware that any credit due for defective product is not processed and issued until the defective item has been returned to Architecturals New Jersey LLC. Any required replacement product is invoiced at the regular unit price as it is shipped. All items returned must be packaged in order to insure that credit due is processed efficiently, and to protect against any further unnecessary damage to the product. Proper packaging includes an adequate pallet, proper top and edge protective covering, and items preferably stood on edge. Items not given adequate packaging protection during return shipment may void the warranty.

Architecturals New Jersey LLC supports our customers with a warranty that covers defective conditions based on industry standards of acceptability. We take a fair and objective view of any warranty situation, but it is important to understand that a warranty does not cover any and all problems that may occur. We urge you to call if you have questions or need further clarification on our warranty conditions or relating to any specific situation that you may encounter. We can require that an inspection be made by one of our employees prior to adjustment or replacement.
